## Application procedure

Apply for admission to your field school by the stated deadline. Aside from the Standard Eligibility Requirements, special requirements may apply. Only a complete application package will be considered.

### A complete package includes:

- this **application**, completed and signed in **THREE** places:
  - the application information you provide;
  - the Participant Code & Refund Policy
  - the Liability Waiver
  
- a **\$500 deposit**. This will be refunded if your application is not accepted.
  
- a **photocopy of the photo page in your passport**.  
Your passport must be valid for the time period covering the field school AND for the **SIX MONTHS** following.
  
- two wallet size photographs**.
  
- a **recent transcript** of your academic work.
  
- two letters of reference** from an instructor\* or previous employer. Form are provided herein.  
\* *one referee must be a current nursing instructor.*
  
- a **one-page resume**.
  
- a typed **statement of interest** detailing

- (1) your reasons for wanting to participate in the field school and
- (2) your previous international experience.

## Standard Eligibility Requirements

Applicants must be nineteen (19) or older before departure and be in good academic standing. Students under nineteen require permission of their parent/ guardian. Qualified students from institutions other than Camosun College are eligible to participate, but must gain admission to **CAMOSUN COLLEGE** as Visiting Students. Please contact **CAMOSUN COLLEGE** International for more information and application forms. Note that only complete application packages will be assessed.

## Costs

Please note that the senior's tuition exemption is not applicable to field school programs. Also, note that international tuition fees are charged to international students. Student loans may be available to those Canadian citizens or permanent residents/landed immigrants who are normally eligible.

## Decisions regarding participants

A selection committee will be selecting qualified participants, with decisions to follow in approximately three weeks after the application deadline.

## EARLY DEPARTURE, WITHDRAWAL, OR PROGRAM CANCELLATION

Students are required to stay at the program location until the final date of the program as announced in the program materials. Students are expected to complete the academic program including all examinations and submission of papers prior to departing the site. There are several circumstances that may force a student to leave a program early or withdraw from a program, for example, a serious accident or illness, a severe psychological problem, or a family problem. In the case of a student who, due to emergency circumstances, is forced to depart early or is unable to complete an aspect of the requirements for one or more courses, Camosun College will report an **Incomplete** on the student's transcript. If an emergency situation forces the cancellation of a program prior to the end of a session, Camosun College will make every effort to secure alternative arrangements for students to complete their academic work.

Camosun College reserves the right to cancel a field school program due to insufficient enrollment or other factors beyond its control. In case of program cancellation, participants are provided with alternative program options or are given the option to defer participation to another term. If the student does not opt for an alternative program or a deferral, Camosun College refunds the \$500 deposit, and all additional fees paid.

## PARTICIPANT CODE FOR FIELD SCHOOLS

A Field School is a unique academic opportunity in which the environment becomes the classroom and learning is not confined to reading texts or attending lectures. A Field School is exceptional because it takes place largely in a country and culture often far removed from the Canadian norm. The laws and legal system as well as modes of behavior, dress, cuisine, habits, expectations and styles of interpersonal communication are all likely to be markedly different from the Canadian experience.

All participants of a Camosun College Field School must be a minimum of nineteen years of age. As such, all are legally adults and will be expected to conduct themselves accordingly. All participants will be seen as representatives of Camosun College, and often will be in close contact with colleagues from Camosun College's partner institution overseas.

The pre-departure orientation session is mandatory. Students who for any reason are not able to attend the session have to contact Camosun College International immediately and make alternative arrangement for an orientation meeting.

The Camosun College "Student Conduct Policy" (<http://camosun.ca/about/policies/education-academic/e-2-student-services-&-support/e-2.5.pdf>) as well as "Harassment Policy" (<http://camosun.ca/about/policies/operations/o-5-human-resources/o-5.10.pdf>) apply to participants in a Field School. Additionally, any conduct which contravenes the laws of the host country, puts in jeopardy the safety of any participant of the program or member of the partner institution, seriously disrupts the delivery of the program, violates the rules and regulations established in good faith by the accompanying Camosun College faculty member, or detracts in a substantial way from the learning environment, will not be tolerated.

The Camosun College faculty member accompanying the Field School is the final authority for decisions related to participant conduct. The faculty member has the authority, with grounds and without recourse to parties on the college campus in Canada, to withdraw participants from the Field School program. If a participant is withdrawn from the Field School or leaves voluntarily, that participant must leave the group immediately.

Application for, payment for, and participation in the Field School program, constitute acceptance of the terms of the Field School, including the academic content, length and location of the program, the terms of participant conduct as well as payment schedule, deadlines and amount.

## REFUND POLICY FOR FIELD SCHOOLS

### Deposit

Field School applications must be accompanied by a \$500 deposit. If an applicant is not accepted into the field school, the deposit will be returned in its entirety. Otherwise, the deposit is not refundable.

### Refund

Extenuating circumstances such as a personal or family medical emergency may allow for a full refund. The request for a refund must be submitted in written form together with proof of the emergency. An inability to raise sufficient funds for participation cannot be seen as an emergency. In exceptional circumstances, such as when proof is provided that an applicant is denied a student loan, a partial refund may be considered.

Payments will be returned less any costs that have been paid for airline tickets, accommodation, or other expenses for the field school. As such it is recommended that participants take out cancellation insurance on their flights.

### Withdrawal

If a participant is withdrawn from the Field School or leaves voluntarily, the balance of funds paid for participation in the Field School will not be refunded. There will be no refund of tuition or other academic or administrative fees.

The affected participant is then personally responsible for all costs incurred as a result of early departure, and is personally responsible for organizing travel arrangements for return to Canada. Camosun College and its Field School representatives accept no responsibility or liability for any participant who has left the program either voluntarily or by administrative withdrawal.

A participant withdrawn from the Field School may exercise a right of appeal within three calendar months of withdrawal from the program.

## RISK ASSUMPTION AND LIABILITY WAIVER FORM

### PREAMBLE

Participation in the Camosun College Field School Program (the "Program") is completely voluntary. Most of the courses offered through the Program are available at the campuses of Camosun College and other colleges. Applicants are not required to participate in any part of the Program in order to complete their diploma or degree.

All participants in the Program are required to execute this Risk Assumption and Liability Waiver Form, through which the participants assume all of the risk attendant with their participation in the Program and release Camosun College, its employees and agents and representatives from any and all claims which might arise as a result of their participation in the Program.

The Camosun College Field School Program is an exceptional educational opportunity, but it is not without certain risks, dangers, and hazards to which all participants may be exposed. These include, but are not limited to the risk of, personal injury, death, property damage, expense and other loss, delay or inconvenience, and course cancellation or curtailment

The Statement of Risks set forth below is intended to inform participants of the general nature of the risks associated with participation in the Program. It is not intended to be an exhaustive list of the various risks to which participants may be exposed as a result of their participation in the program

### STATEMENT OF RISKS

The Program involves all the risks inherent in international travel. The majority of the Program will take place in the location identified. There are significant risks, dangers and hazards to which all travelers are exposed. These include, but are not limited to, a poor road and transportation systems, tropical diseases, exposure to wildlife, political instability and threats of terrorism. The medical facilities there may be of a lower standard than in Canada. Some locations may have a high incidence of crime as well as malaria, hepatitis, HIV, AIDS and other infectious diseases.

Camosun College will be using the services of independent travel agents, airlines and local travel companies. Camosun College cannot accept responsibility for the conduct of these independent agencies. It is always possible that the Program might not be completed or individual courses or activities may be curtailed or cancelled, due to weather, illness, political disturbances, terrorism, motor vehicle accidents, transportation problems, tribal violence, failure to perform on the part of the travel agents, airlines or safari companies, problems relating to customs, immigration or visa requirements, or other circumstances either within or beyond the control of Camosun College.

### ASSUMPTION OF RISK BY PARTICIPANT

I understand that as a result of my participation in the Program I may be exposed to various risks and that I might suffer loss or damage as a result. I freely and voluntarily accept and assume personal and sole responsibility for any loss or damage suffered by me as a result of any aspect of my participation in the Program.

### LIABILITY WAIVER

I RELEASE AND SAVE HARMLESS Camosun College, its employees, agents and representatives from any and all liability for any loss, damage or expense that I may suffer as a result of my participation in the Program while participating in the Program, or after the termination of the Program I engage in activities that are not sanctioned by Camosun College..
