PROGRAM INFORMATION

The BBA (Accounting Major) credential is officially recognized by CPA Canada. Graduates can apply directly to CPA PEP upon completion of the BBA, as the BBA includes all of the necessary prerequisites.

Elective Guidelines – Seven Elective Courses

One (1) elective: Any 100 or higher level course

Two (2) electives: Any 100 level or higher non-School of Business courses

Four (4) electives: Any 200 level or higher courses

Exceptions

Students may only use one of two or more courses with equivalent content and different names for credit towards completion of program credential.

Courses NOT acceptable as elective credit toward the Business Administration Diploma, Accounting Option, or the Bachelor of Business Administration, Accounting Major.

Some additional courses are not acceptable as elective credit toward the diploma and degree. All electives should be chosen in consultation with the Department Chair or an Academic Advisor.

Credit to the accounting diploma and BBA may be obtained for only one of a pair or group of courses identified as having content that has significant overlap.

- Examples are: ACCT 250 and ABT 281; BUS 143 & BUS 242; BUS 290H & BUS 290; MATH 100 & MATH 108; MATH 105, & MATH 107, & MATH 115; STAT 116 & BUS 230; MATH 126 & MATH 222; SFL 300 & BUS 214; SFL 310 & PHIL 330; BSYS 494 & BUS 220.

There may be other examples. Please consult with the Department Chair or Academic Advisor for more information.

- ^a Two university transfer math courses are required and BUS 231 may be used as one of the two math courses.
- ^b A 200 or higher level university transfer course in one of the following areas: Anthropology, Art, English, History, Music, Languages, Philosophy, Political Science, Psychology, Sociology (not incl. ECON)
- ^c BUS 400 has not been offered since 2009.
- ^d A 200 or higher level economics or finance course, excluding FIN 230 & FIN 231, is required in addition to FIN 210. FIN 220 may be used for this requirement if BUS 241 is also taken.
- ^e Students interested in the CPA program should select Bus 241.

BBA Program Completion Requirements

To qualify for a BBA (Accounting Major) credential, a student must successfully complete all 40 academic courses with a minimum cumulative GPA of "C+" (65%), plus 420 hours of applied work experience. The applied work experience can be satisfied by completing ACCT 499 Non Co-op Work Experience **or** BUS 101 and BUS 201. A minimum 10 of the 40 courses, including ACCT 480 and at least 7 300 level or higher ACCT courses must be taken at Camosun.
