


### COVID-19

We're ready for you. The college is planning for a mix in the delivery of courses following guidelines from the Provincial Health Officer, WorkSafe BC and the B.C. Government.





• full-time, masters level curriculum, degree admission requirement

#### Mental Health & Addictions (MHA) Certificate

• full-time, prepares for frontline support positions, admission requirements include high school diploma with C+ in English 12

#### New: Mental Health, Addictions, & Criminal Justice (MHACJ) Advanced Certificate

• interprofessional approach, enhancing services and supports for individuals with mental health &/or substance use challenges in contact with the criminal justice system



### Mental Illness & Addiction Concepts

#### **Mental Disorders**

Mental illnesses are... disturbances in thoughts, feelings, and perceptions that are severe enough to affect day-to-day functioning.

- Canadian Mental Health Association, 2020

#### Addiction

... a complex disease, often chronic in nature, ... affects the functioning of the brain and body.... causes serious damage to families, relationships, schools, workplaces, and neighborhoods... most common symptoms ... severe loss of control, continued use despite serious consequences, preoccupation with using, failed attempts to quit, tolerance and withdrawal.

Addiction can be effectively prevented, treated and managed by healthcare professionals in combination with family or peer support.

#### Homelessness

Mental health and addiction problems impair capacity to function adaptively; persons who are affected by severe forms of these conditions, particularly concurrently affected, are at significant risk for homelessness.



#### **Concurrent Disorders**

#### **Prevalence**

- People with a mental illness are twice as likely to have a substance use problem compared to the general population.
- At least 20% of people with a mental illness have a co-occurring substance use problem. For people with schizophrenia, the number may be as high as 50%.
- People with substance use problems are up to 3 times more likely to have a mental illness. More than 15% of people with a substance use problem have a co-occurring mental illness.

#### In BC

- An estimated 130,000 individuals meet the criteria for concurrent disorders) in BC alone
- Vancouver Police Department survey in the Downtown Eastside showed that 50% of all emergency calls were found to involve people with mental illness or substance use

## Psychosocial Rehabilitation (PSR): A Foundation of Practice in the MHA Program

- A holistic approach that places the person not the illness at the center of all interventions
- Psychosocial is... the close relationship between psychological, social, and environmental effects
- The wishes of the person being served direct the rehabilitation process
- Effective rehabilitation and recovery builds on a person's strengths and helps the individual to compensate for the negative effects of the psychiatric disability

The concept of recovery is rooted in the simple yet profound realization that people who have been diagnosed with mental illness are human beings... The goal is to become the unique, awesome, never to be repeated human being that we are called to be... Those of us who have been labeled with mental illness are not de facto excused from this most fundamental task of becoming human... because many of us have experienced our lives and dreams shattering in the wake of mental illness, one of the most essential challenges that faces us is to ask, "who can I become and why should I say 'yes' to life?"



#### **MHA** Practice

The support worker works side-by-side, in the context of a therapeutic relationship, with individuals who are living with mental health &/or substance use challenges... includes supporting individuals in daily activities such as leisure & recreation, nutrition & meal preparation, physical self-care, budgeting, housecleaning, medication monitoring, and social skill development.

Learning and applying self-management skills can assist people to recognize and manage their illnesses, with the assistance of specialized services and professionals when required.

Graduates are not qualified to work as counsellors unless they have other training or post-secondary credentials

- opportunity to integrate knowledge & skills to assist individuals in mental health &/or addiction settings
- opportunity to explore the role of the mental health & substance use worker as a member of an agency team
- Practicum Coordinator and Program Leader assign placements to students based on student demonstration of skills and knowledge, performance in courses, past experience, personal suitability, & available modes of transportation
- the intention is not to obtain employment at the practicum site, but to develop and apply transferable skills and knowledge

### What if you are in recovery from mental illness or substance use?

- Students may find the content elicits strong emotions; this can be difficult for those managing unresolved issues or are recovering from addiction/mental illness.
- Discussions and activities to learn support strategies will be about selfharm, disordered eating, weight management and nutrition, abuse and trauma, and substance use.
- Those actively using illegal substances, or substances other than for prescribed conditions, are strongly advised to delay starting the Program.
- Students are encouraged to take advantage of services at Camosun and to be pro-active in self-care:
  - Center for Accessible Learning (CAL)
  - Counselling



### Is MHA work for you?

If you like the idea of participating in client-focused treatment and recovery supports for persons with mental illness &/or substance use challenges, perhaps work in the field of mental health & addictions is right for you.

Is your answer "yes"?

- Do you value working in fluctuating, recovery-focused settings?
- Are you willing to assist with personal and physical self-care?
- Are you willing to effectively respond to crisis situations (e.g., escalating behavior, potential overdose, active substance use)?
- Do you have or want to develop good communication skills?
- Do you enjoy working on a team yet can work independently?
- Do you cope effectively with personal issues?

The work is challenging, active, and requires good time management and self-care. One needs to be self-reflective, open-minded, and self-directed.

### **Potential Employment Considerations**

There are a variety of roles and programs in mental health and addictions, as well as much diversity in those you will be supporting. Although there is no specific job title for our graduates, this list includes potential types of positions you may be qualified for:

Employment postings may indicate a length of time for experience (e.g., two years), it is important not to let that dissuade you from applying. Most postings indicate the ideal qualifications and in the mental health and addiction fields there is a shortage of trained workers. On the next page you will find information on organizations you may be qualified to work for with the MHA certificate, depending on the specific position and your education and experience.

### Is the MHA Program a good fit at this time?

#### Students are expected to...

- be open, willing to give and receive feedback, critically evaluate their own performances, and make themselves available for group work and study outside of scheduled class hours.
- engage in interpersonal communication, resolve conflict, and negotiate in a context of diverse beliefs, values, and learning styles through mature and productive processes.

When considering ability to handle the physical and emotional demands of the Program and human/health services, students should consider the realities such as...

- Classes are 2-4 hours and practicum shifts are 7-12 hours, requiring mental focus and physical stamina
- If employed during practicum, avoid graveyard shifts as you must be rested and alert at the practicum site
- Student and professional roles...
  - include small group/team work and public speaking
  - o require conceptualization and clear written communication skills (e.g., grammar, spelling, & punctuation)
  - o include comprehensive assignments and document formats (e.g., journal article reviews, reflective essays, research papers, & funding proposals)
  - o require personal phones/devices be silenced, out-of-reach



### Are you ready to be an MHA Student?

#### Is your life organized so that you can...

- attend 12-24 hrs of classes each week?
- complete ½ 2 hrs of reading and/or assignments every day?
- focus your energy and thoughts on your course work?
- practice good self-care and time management?
- participate in practicum shifts that start early in the morning, run into the late evening, occur on weekends, and may require travel?

#### Are you able to:

- Provide practice sites with a clear criminal record check?
- Work in a blended (partially online) program of study?

#### Have you considered delivery options:

**Full-time**: comprehensive, 40 hrs/wk classes & learning activities **Part-time**: if available: less intense, 20 hrs/wk classes & learning activities,

better option if you intend to work while pursuing your studies



### **Registration Process**

- Submit an application with your admission requirement(s) and registration fee
- Applications are date-stamped
- The first fully-qualified students are offered seats in the program
- A \$175 non-refundable deposit is required when offered a seat, applies to first term tuition



### MHA Admission Requirements & Recommendations

- A letter grade of "C+" or higher in English 12 or TPC 12 or assessment
- Submit a minimum **300-word statement** of intention outlining career goals and motivation for entering the program, by email in **PDF** file directly to:

- Completion of CFCS Mental Health & Addiction **Program Information Session** prior to the first day of class and completion of information session attendance survey.
  - **Complete** Student Readiness Survey at the bottom of the information attendance survey.
- Because the MHA Program is blended delivery students must participate in an orientation to online Desire2Learn (D2L) system and tools prior to & during the first week of classes
- Criminal Record Check (next page)
- Computer skills including keyboarding, word processing, Internet access and navigation, and email management.
- Involvement in **volunteer** or work experience in human services prior to entering the program is encouraged
- Please consult the <u>Student Success</u> to help you determine if you are ready to become a student, and where to find the appropriate support resources on campus



#### **Current Criminal Record Check & Vulnerable Sector Search**

During this program, you may be working with vulnerable adults. In order to participate in practicum, you must complete a Criminal Record Check (CRC) through the Ministry of Public Safety & Solicitor General's Criminal Records Review Program (CRRP).

Upon registration, Camosun will email you information on how to complete the <u>CRC process</u>. You are responsible for all associated costs (CRCs obtained by other methods will not be accepted).

#### Required and Strongly Suggested

#### Required

- A negative TB skin test or a negative chest x-ray. Evidence must be dated no more than six months before practicum start date. Students are responsible for the cost of testing.

  - Nova Travel & Immunization Clinic #206, 1964 Fort St.
  - TMVC Victoria 771 Vernon Ave. #206 Gateway Plaza
- Evidence of immunization status. Failure to comply with immunization guidelines could result in... barring the individual from practicum setting until proof of immunity is provided ... could impact a student's ability to successfully complete the ... practicum placement course.


**Drivers license:** required for Island Health practicum and employment; lack of a license will not be a barrier to practicum yet it may limit employment opportunities


