Meeting called to order at 10:01am

1. Welcome

Lane Trotter, Committee Chair extended a warm welcome to all in attendance and expressed grateful acknowledgement of the Coast Salish Territory on which the meeting took place.

2. Studio Development Status Update and Questions

- Members were provided with and overview of the RFPQ process as well as an
 update of progress to date. It was confirmed that the Evaluation Committee has
 reached an agreement to move forward with one of the several submissions made.
 At present, there will be no movement to proceed to the next stage of the process
 with the successful proponent. Rather, engagement discussions have been initiated
 and will continue. To that end, Lane and Geoff have already travelled to Vancouver
 for an initial discussion. There is much to do and more discussions will take place in
 the coming months.
- A member asked for a break-down of steps in the procurement process and Geoff provided details.

Overview of Due diligence steps taken to date:

- a) Land Title search was completed September 14, 2022
- b) Potential for traffic impact continues to be a major and ongoing focus

- c) Corvidae Environmental Consulting has been contracted to undertake an environmental review of the land. Receipt of their report is anticipated in January 2023
- d) An arborist has been engaged and their report has been received.
- e) Thurber Engineering has been engaged. A findings report is anticipated soon.
- Subdivision application has been initiated however feedback from the Municipality of Saanich will be needed prior to the application process being moved forward
- g) A consultant has been hired to work with local First Nation groups
- Ministry representative Phil Hancyk confirmed that road development funds are
 accessible however the ministry will need to receive many more details about how
 the funding will be utilized before such funding could be released. A meeting will
 be planned so that details can be shared with representatives of the Capital Asset
 Management branch of the ministry. Key attendees will be Alison Prince, Geoff
 Wilmshurst and Ian Tol
- Further discussion ensued on the topic of time-lines. It is anticipated that time-lines may become more clear mid-way or later in 2023. Phil assured that his team and department are ready and willing to assist when the time is right
- A list of Ministry paperwork requirements was requested and Phil agreed to provide
