



2023/24 Coast Capital Trading Up Initiative Application

In 2022, Camosun College, with support from *Coast Capital Savings Federal Credit Union*, implemented this program to help students achieve their education goals and begin a fulfilling career in the Skilled Trades.

For over 80 years, *Coast Capital* has been helping their members achieve their goals by unlocking financial opportunities that positively impacts people and communities. The *Coast Capital Trading Up* initiative at Camosun College will help support this goal, by supporting foundation and apprentice students from all demographics to find success in their education and skilled trade careers.

Eligibility Criteria

To apply for *the* Coast Capital Trading Up Initiative students must:

- Be a Canadian citizen or a permanent resident;
- > Be applying for admission to an eligible full time skilled trade program of study (see eligible programs below);
- Applicants must be willing to engage in two separate interactions with Program Coordinator throughout their training period, in regards to the Coast Capital Trading Up Initiative
- Students must also be willing to report to the Program Coordinator on their successes throughout their academic journey.
- > Preference will be given to individuals that are unable to access other pathways of funding

Successful applicants may receive the following: (Maximum of \$4,000)

- Educational Costs: tuition, student fees, books, supplies
- Living Supports: housing, transportation, child care costs
- Supports may also include: Tooling and Personal Protective Equipment (PPE), specific job ready technical certifications or essential/soft skills [e.g., WHMIS, Aerial Lifts, Fall Arrest, Forklift Training, Conflict Resolution, Computer Literacy, etc.]

- > 2. Section 5- Statement/Supporting Information (attached to application submission)
- > 3. Coast Capital Declaration and Budget Sheet

Application Deadlines

Applications for the Coast Capital Trading Up Initiative will be accepted year-round but applicants may apply no earlier than 8 weeks prior to the start of their program. Applications will be accepted for the first 10 days of eligible trades programs. *(Some exceptions may be considered)*
